


THEY RESIDED IN THE HOMES WE PROVIDED, SO THEY COULD ATTEND SCHOOL. MANY OF THESE CHILDREN ARE ORPHANS OR THEIR FAMILIES ARE TOO POOR OR TOO ILL TO CARE FOR THEM. WE PROVIDED FOOD, CLOTHING, SHOES, SCHOOL UNIFORMS, SCHOOL SUPPLIES AND TOILETRIES AND OTHER EVERYDAY NECESSITIES.
